About the Master Plan

In June 2003 the U.S. Environmental Protection Agency, the Guam Waterworks Authority and the Government of Guam entered into an agreement called a Stipulated Order. Under this agreement the Guam Waterworks Authority, under EPA supervision, is undertaking a broad initiative to restore its facilities and to provide safe, reliable service to the island, while meeting all regulations.

during the next 20 years to provide reliable water and wastewater service. It also identifies ways to improve service now.

Working Together

This master plan is different from previous master plans because the Stipulated Order will likely lead to a regulatory roadmap GWA must follow. In addition, the Water Resources Master Plan is taking a "team" approach. GWA staff and consultants are working together as an integrated project team to gather data and recommend asset management and capital needs. This effort will also involve working with the entire GWA staff during the data gathering phase. GWA employees are receiving extensive training in new technologies that will enable employees

to work more effectively and efficiently in the future. The public is an important team member too. Last October GWA met with residents of villages throughout the island and is using that input to help develop the master plan. GWA will continue to provide information to the public and seek their input throughout the process.

Schedule

As part of the Stipulated Order, the EPA requires GWA to make specific improvements or submit specific information to the EPA by predetermined dates. GWA has met most of the EPA's deadlines, but not all of them. GWA shares the EPA's goals of improving our system. GWA is making good progress on the master plan, working closely with the U.S. EPA and the Guam EPA to achieve the system improvements needed to provide excellent water and wastewater service to GWA customers. The master plan is scheduled to be completed in 2006.

Common Questions

What's included in a master plan?

Developing a master plan is more complicated than it sounds. It is truly a comprehensive document that will contain all the information needed for GWA to provide excellent service into the future. Here are some of the things GWA is working on as part of the master plan:

- Population forecasts
- Land use forecasts
- Water demand trends
- Detailed inventory of all facilities, including the condition, upcoming maintenance requirements and expected life spans of those facilities
- Digitizing all system maps and drawings
- Geographical information system (detailed mapping of island water and wastewater utilities)
- Hydraulic models
- Financial projections and plans
- Description of current and planned construction and rehabilitation projects

- Staff training
- Peer reviews of master plan
- Community activities
