## All Qualified Bidders:

This addendum is issued to modify the previously issued bid documents and/or given for informational purposes and is hereby made a part of the bid documents. Failure to acknowledge receipt of this addendum shall be grounds for the bidder's disqualification and rejection of the bidder's proposal.

## 1. Part A - Pre-Bid Site Visit

A pre-bid site visit will occur after the pre-bid conference on August 22, 2018. The site visit will begin at approximately 11:30 am at the Northern District Wastewater Treatment Plant and will last approximately one hour. Interested bidders should be prepared with the appropriate Personal Protective Equipment for a wastewater treatment facility. Safety shoes, safety vest, and sun protection are recommended.

## 2. Part B – Bid Requirements

Bid Requirement Section 00800, Supplementary Conditions. Article 2 – Preliminary Matters, Paragraph SC-2.01 Delivery of Bonds and Evidence of Insurance. Delete paragraph in its entirety and replace with the following:

SC-2.01 Delete Paragraphs 2.01 A., B. and C. in their entirety and insert the following in their place:

B.

Evidence of Contractor's Bonds and Insurance: Contractor shall submit all required bonds and insurance policies for Owner review and approval. Contractor shall also deliver to Owner copies of the policies of insurance (including all endorsements, and identification of applicable self-insured retentions and deductibles) required to be provided by Contractor in Article 6. Contractor may block out (redact) any confidential premium or pricing information contained in any policy or endorsement furnished under this provision. Once all required bonds and insurance policies are approved, Owner will issue the unexecuted counterparts of the Agreement to Contractor.

## 3. Part C - Specifications

Specification Section 02277, Articulated Concrete Block Mattress System. Part 1 General, Paragraph 1.05.A.1. Delete paragraph in its entirety and replace with the following paragraph:

1. Combined experience summary of Contractor and Manufacturer demonstrating a minimum of 10 years' experience supplying and installing mat systems for submarine pipeline protection with descriptions and references (name, affiliation, telephone number and email address) for at least five projects in the past 10 years.
