### INVITATION FOR RE-BID

The GUAM WATERWORKS AUTHORITY will receive sealed bids for the **NORTHERN GUAM LENS AQUIFER (NGLA) MONITORING SYSTEM EXPANSION PROJECT FOR THE GUAM WATER AND WASTEWATER INFRASTRUCTURE IMPROVEMENTS PROGRAM (RE-BID)**, GWA Project No. W20-001-OEA, OEA Grant OCON676-16-03 and OCON676-21-07. Bids will be accepted until **3:00 pm**, Chamorro Standard Time **April 26, 2021**, at the Gloria B. Nelson Public Service Building, 688 Route 15, Mangilao, GU 96913 at which time and place all bids will be publicly opened and read aloud. The contract time for the project is **430** calendar days for the Base Bid portion of the work. All bids must be accompanied by a Bid Bond in the amount of fifteen percent (15%) of the total bid amount. Bid security may be in the form of a bid bond, certified check or cashier check made payable to Guam Waterworks Authority.

A non-refundable amount of Fifty dollars (\$50.00) is required for the purchase price of every electronic copy (flash drive) of the bidding documents which will be available at the GWA Engineering Division by appointment only on or after **March 26, 2021**.
