1	SECTION 33 21 00 Monitoring Well General Requirements	 Monitoring Well Surface Casing – Can we just install a 40-foot surface casing down to 38 feet and the 2-feet sticking above the concrete slab? The casing comes in 20-foot section. A 42- feet casing will require a welded 2 feet of casing. 	The proposal to install a 40 ft casing down to 38 ft with the top 2 feet exposed is acceptable.
2	Section 00410 Bid Form	DOW-NWF1 – Screen length showed 297 LF. Can we make it 300 LF instead? This way we don't need to cut 3-feet on a 10-foot section of the screen that will lose the threaded end or order a customized 7-foot section. Or can make it 290 LF.	The screen length can be increased to 300 LF as proposed. (A reduction to 290 LF will not be acceptable).
