Qualifications and Experience of Project Team: Specialized experience and qualifications of designated project personnel to perform the required services. This includes the availability of resources and evaluation of the Project Organizational Chart to complete the work.	35 Points

Performance Record: A demonstrated track record of effective planning, scheduling and on-time delivery performance on those schedules. Successful performance on projects that is similar in nature and scope. A demonstrated track record of teamwork, cooperation, fair dealing, client service and relationships of mutual trust and confidence. The absence of a pattern of adversarial relationships, claims and litigation.	15 Points
