4.	Please be aware that the bid requirements on Page 38. Section V.6. Warranty, states that "The bidder shall also warrant all goods and servicesfor a period not less than three (3) year. "Adds a very significant cost to the bid price.	No changes to this requirement.
5.	GWA did not clearly answer Response to Inquiries No. 3, Question 2. BAA qualifying countries are not TAA compliant countries. Therefore, we will restate the question.  Can BAA (Buy American Act) qualifying countries be compliant to this bid?	The Buy America Act doesn't specify particular countries as being part of its coverage. Instead, it focuses on where the products are manufactured. As such, it applies to products made in the United States or its territories.  Section 6. Warranty (under V. Special
