

Our trucks come 2.4L 4 cylinder turbocharged, Is this acceptable?- The bid in general indicates that a loaner vehicle is to be provided. Currently, Atkins Kroll, Inc. does not offer a loaner vehicle. Is this acceptable?	Amendment for the following line items 4.1 and 5.1: Engine: Previously Read: 2.7L or larger, 4-cylinder gasoline powered. Amended to Read: 2.4L 4-cylinder or larger Turbocharged accepted. Amendment for the following provisions: IV. Special Provisions, Section 6 "Warranty and Services (d). Previously Read: In the event any item to be procured under this bid is not available to GWA for a period of seventy-two hours, the vendor shall provide a replacement of equal or greater capacity than the item being serviced at no cost to GWA. Amend to Read: In the event that any maintenance or service will require a vehicle to be kept longer than twenty-four (24) hours (overnight), GWA shall be provided an equivalent or better "loaner" or rental vehicle as an alternative
