If granted approved by tomorrow, I wager that we should have enough time to get material here, schedule a jar test & wait for results, and put together a proposal in a timely fashion. Otherwise, if the extension is granted around the 3 rd week of July, it we would still have only the same amount of time as we did when we first asked for the extension. Jar testing can be scheduled through the GWA Procurement office with concurrence with GWA WW Ops.</p>
