1.	<p>Bid Item # 3 and 4 Toughbook</p> <p>The bid specification does not state you need LTE or GPS, but I would like to confirm, as the product is not returnable once purchased unless there is a warranty issue to fix.</p> <p>Meaning: LTE (Long-Term Evolution) refers to a built-in cellular data connection that allows you to access the internet without relying on Wi-Fi or tethering to your phone.</p> <p>"GPS" stands for Global Positioning System. It's a technology that uses satellite signals to determine a device's location on Earth. GPS on a laptop can be used for navigation, tracking, and mapping, often integrated with software like mapping applications or location-based services.</p>	<p>No, Toughbook's only require Ethernet and Wi-Fi capabilities.</p>
