Regarding our clarifications on the special provisions, we are aware of the 15% Bid Security but we would like to inquire if the <u>performance bond</u> for this project is also 15%?	<p>Page 25 of the IFB, Section V., subsection 1, states:</p> <p>All bidders are required to submit bid security in the amount of 15% of their total bid amount under the “Base Bid” which must also indicate that the security is not only for a bid bond, <u>but also for performance under this Bid</u> as required by 5 G.C.A. 5312. Failure to submit a proper bid bond will cause the bid to be rejected.</p> <p>In summary, the 15% bid security is not only for the bid bond but for the performance bond as well for this IFB.</p>
2.	Due to all the new changes, can the agency update us with total linear footage and anything that is not going to be done and cancelled to allow everything to be more clear when we submit our bid pricing.	See attached revised Bid Cost Forms.
